## Marketplace/MCAC

### FEDERAL HEALTH INSURANCE MARKETPLACE

If you are not eligible to enroll in a Medicaid program through your state, you may be eligible to purchase health insurance through this option.

Medical Care Access Coalition (MCAC) is now accessible on the campus of Dickinson County Healthcare System and is available to assist in applying for Medicaid.

MCAC offers prescription assistance and free unbiased Medicare / Medicare supplements and Medicaid counseling for Michigan and surrounding area.
